The Danish Board decided that the EBA Delegate should attend the annual Bonsai Exhibition of EBA and all relevant meetings and any events.

News from Spain

XXIVº National Spanish Bonsai Congress, Bembibre (Leon)

This year's Spanish National Bonsai Congress (XXIV o) took place on 13th and 14th of October at the small mining and vine growing town of Bembibre (Leon Castilla), home town of the since one year new AEB-president, Juan Carlos López Alfonso.

Its site was the impressive Bembibre Arena, rather big however for the not precisely great number of delegates.

The exhibition of Bonsai included trees from King Juan Carlos and the former Prime Minister, Felipe González Márquez, as well as excellent Bonsai from several (unfortunately by far, not all) Spanish Associations.

The actual national crisis is at the root of many absences, and it appears that many clubs are fighting hard to survive for blatant lack of means, apart from the fact that precisely in these times people are rather prone to shy responsibilities (and unpaid-for work).

Nevertheless, the organizers Asociación Mediterránea del Bonsái, had worked out an interesting program, but partly carried out: demonstrations by Antonio Torres and this year's NT participant at Ljubljana, Felipe Leal, New Talent Contest (won by Samual Martínez), infant workshop and painting, conferences about ceramics, Kusanomo, Ikebana, etc..

The delegates also were offered very tasty and abundant local meals, the usual opening and closing speeches with Authorities plus back-slapping, and all very well attended by the organizers.

However, this XXIVth congress unfortunately did not give excessive hope for a truly positive development of AEB in the near future.

Quite different from the (professional) VI^oConcurso Nacional "Luis Vallejo" held on 10th and 11th of November at Algobendas (Madrid), were amongst others 48 Bonsai from all over Spain were judged by experts like Luis Vallejo (director of the Municipal Bonsai Museum), Ferrand Bloch and Mario Komsta et al, apparently there with large presence of bonsaists.

Professionals against (or with?) amateurs, that's now the question, I believe.

News from the UK

Royal Horticultural Society Show - Chelsea, 22nd - 26th May, 2012

The Federation of British Bonsai Societies participated in this years' R.H.S. Chelsea Flower Show and once again, it proved highly successful, receiving another Gold Medal award. Congratulations to all those who played a part in bringing the display together.

Gardeners World Live - National Exhibition Centre, Birmingham: 12th - 17th June, 2012

Local bonsai societies were approached by the Royal Horticultural Society to put on an unusually large display at Gardeners World Live this year. The event is held annually at the NEC, Birmingham. The display covering 65 feet by 43 feet included a Japanese Garden and educational display.

The Federation's participating societies were the Ambion Bonsai Club, Heart of England Bonsai Society, Midland Bonsai Society, Northampton Bonsai Society, Redditch Bonsai Group, South Staffs Bonsai Society and the Friends of the National Bonsai Collection. Although a complex project and very much experimental in design, the stand succeeded in gaining a good Silver Gilt award and proved a great draw with the public.

Bonsai in Wales, 26th & 27th August, 2012

Over the August Bank holiday weekend, Tredegar House near Newport, South Wales, was host to "Bonsai in Wales", an event incorporating a superb exhibition of bonsai trees, some wonderful demonstrations and range of materials for sale from a number of bonsai traders.

The trees exhibited encompassed a range of styles and species and comprised some quality material, much of which would have graced a major international exhibition of trees. They certainly reflected the degree of excellence to which British bonsai has been progressively achieving over a number of years and continues so to do.

The demonstrators, Alex Evelyn, Andrew Arthur, and Kevin Willson, together with members of his School, provided some creative trees based on the raw material. Kevin worked for full two days and, with his trademark carving techniques, produced a spectacular bonsai.

The event was also an opportunity for the Federation to hold one of the heats for this years' Amateur New Talent competition. Whilst the raw material (Juniperus chinensis) was not necessarily the easiest to work with, the contestants nonetheless produced some worthwhile trees.

Capel Manor Bonsai Exhibition, 14th October, 2012

Capel Manor once again provided the venue for this years' Autumn Show, organised by the Bonsai Group. Together with a range of trade stands providing most of what any bonsai enthusiast could wish for. The principle feature was the exhibition of trees displayed both by societies and individuals showing quality material, some examples of which are illustrated below.

The event also included the Final of this years' New Talent Competition won by Marcus Watts. He will now represent the U.K. in the European Final to be held in Audincourt

Heathrow Bonsai Show: Sunday, 4th November 2012

The Show, held at Harlington, just north of Heathrow Airport, provided the bonsai enthusiast with a range of trees on display. There were demonstrations by John Hanby; the morning involved John working on a juniper and during the afternoon session, working on a rock planting.



a. Report EBA Board Meeting

The President welcomed all delegates and participants and pointed out that this meeting is a forum of EBA to discuss all matters of importance. He informed together with the secretary the delegates of the topics discussed at the Board Meeting, held yesterday in the afternoon.

Honorary Membership

The president reported on the decision of the board to honour René Vantilt for his extraordinary efforts in promoting EBA. As he will not be present at the AGM the president will hand out the certificate to Marc Noelanders to present it to Rene with the best wishes from members and the board. The members accepted the decision.

Preparations for the election of the Board 2013

The secretary informed members that the election of the Board will take place at the next 2013 EBA Convention in France. The board (Reg Bolton, Vaclav Novak, Marc Noelanders, Jürgen Carocci, Detlef Mostler) will candidate as a whole team for a further period. Because of that the board proposes a joint candidacy of the whole team to the AGM in Audincourt. The election will be announced in the next NL and on the homepage.

Excerpt from the EBA Byelaws

- (6) a. Candidates for the board are nominated to the secretary of the EBA by a Full Member at least 2 month prior to the AGM by letter or e-mail addressed to the secretary.
 - b. If, however, the number of candidates for the board does not reach the number of vacancies, candidates may be nominated by the board.
- (7) a. Candidates for the board have to be a member of their national member organization for at least one year, and must be present at the AGM when their nomination is being considered. Whether or not an excuse for not being present which should be an exception can be accepted, has to be judged by the AGM.
- (8) The candidates must at the General Assembly be at least 18 years old.

b. EBA New Talents Contest ©

The president gave a short description on the course of the NTC.

He was very pleased regarding the nomination of 16 candidates by members. All were present and worked very well during the available period of time.

Reg Bolton and Vaclav Novak organized the whole contest. Kath Hughes did the evaluation together with Malcolm Hughes. The results will be made public at the Gala Dinner.

As well the gifts, given by the Slovenian organisers, and the EBA prizes, Gudrun Benz donated three books as presents for the winners

c. Payment of membership fees

A written report from the treasurer was distributed to the Members defining the latest status of the EBA assets. The financial situation and the report of the auditors. He gave a short report on the Statement of Accounts. The financial situation of EBA is sound. The auditors examined the financial accounts for 2011. They found everything to be regular, correct and accurate. The Auditor's Report was accepted unanimously.

Problems are continuing with San Marino concerning the payment of their membership fees. The board asked the Italian Delegate Leonardo Pettinari he is aware of anything concerning the situation of the Bonsai Club of San Marino.

d. Members and Contacts; presentation Hungary (Magyar Bonsai Szövetség)

The president stated that there is a possible new candidate for EBA Membership: Romania.

Hungary made a presentation. Sandor Varga reported on the foundation of the Hungarian Bonsai Association which was very labour-intensive. He made a short presentation on the 30 year festival of the University Bonsai Club of Budapest. Many friends from Hungary and from foreign countries visited this event. Mr. Varga thanked the members of EBA for their friendly acceptance of Hungary as a new member and asked for good contacts in the future.

e. EBA Homepage

Klaus Buddig made the last updating shortly before the Convention in Ljubljana. The board decided to ask him to provide and give all necessary data to access and administer the homepage. The president will write to Klaus when he returns to England.

The Board is still aware that the updating of the website is a matter of the contributions put together from the members and the board. It is an important task for the members to send information of the yearly activities in their countries for publication on the homepage.

he president asked again for articles to update the homepage and asked for understanding of the problems encountered in the past. The board will look for a solid arrangement to maintain the homepage proper.

f. Newsletter

The date of issue of each new NL is recorded in the previous NL to have enough time for the members to prepare information for the NL. The issue of the next NL is planned for November 2012. g. Future EBA Conventions

Contract France

The Convention 2013 France was confirmed by the board. The Convention Contract was signed by the President and the Secretary. The program will be presented by Jean Marc at the AGM. The application for holding the EBA Convention 2014 by Poland was also confirmed. The program will be presented by the Polish delegation tomorrow.

EBA-Convention Audincourt 2013

Jean Marc Pouillon presented the venue and the program by a slide show. The preparations are running well and as soon as possible the whole information will be put on the homepage of FFB. The exact data for the registration of bonsai will be published in summer. Beside the EBA Exhibition will be also a national exhibition.

After the presentation there was a discussion about the invited demonstrators and the early date of the convention. The board confirmed that the date of each convention is a matter and decision of the hosting country; there are many winter shows in Europe. Regarding the invited demonstrators, the delegates asked the board to add an item to the convention rules that EBA recommends to the organizers of an EBA Convention to invite for the demonstrations a good mix of European demonstrators. The board accepted the proposal and will add such a comment to the EBA Convention Rules.

Payment of the Convention fees:

For those members who are not in the euro zone the board members suggested to allow a payment of the fees on-site at the front desk to save the high costs of a bank transfer.

Trees for the NTC:

The participants discussed the possibility of considering other tree species as raw material for the NTC. No decision was made.

Future Convention applications:

2015 Italy, Lithuania, Czech Republic

Concerning the EBA Convention 2015 Italy and Czech Republic withdrew their applications. Italy postponed the application to the year 2016 and the Czech Republic to 2017. Therefore Lithuania is the only candidate for 2015 and will present its venue at the AGM tomorrow. (see attachment)

Election of new EBA Board.

Please note – any nominations for the EBA Board must be made to the Secretary by 25th March 2013

New Talent Competition.

Those who attended the EBA meetings at the last Convention in Slovenia will remember I suggested that the procedure for Judging the New Talent Competition be changed from the current arrangement – that – each Country entering a candidate must also nominate a Judge. (This year one Country sent a candidate but no Judge.) My intention is to put a proposal to the next RTM & AGM that the Judging of the New Talent Competition be changed for 2014 to a panel of 5 Judges only. Judges will be chosen from a panel of Judges, the panel will comprise of individuals nominated by their member country. It will be the responsibility of the Board of each member country to ensure the people they nominate as a Judge has the experience and knowledge of Bonsai required. The panel members would be rotated on a yearly basis, full details will be published if this proposal is accepted.

Having such a panel will make the administration of the New Talent Competition simpler and also ensure – I hope accurate decisions. It will also obviate the need for so many people – Judges to inspect the material prior to the Competition, at present this seems to cause delays, also only the Judging Panel of 5, will be exclude from viewing the on going work of Candidates during the competition.

Please will you bring this matter to your Board and Members for nominations and opinions regarding this proposal. Another matter regarding the NTC is that I believe the Rules for the Competition require reworking, to this end I will prepare another proposal for a new set of rules. Again your opinion is welcome.
